To make your monthly contributions easy and convenient, simply adopt the underlisted processes:

- Prepare your schedules with PIN of all contributors and raise a cheque for the total sum on schedule.
Note: company should prepare separate schedules for each PFA (if more than one).
- Take prepared schedules and cheque to any Zenith Bank branch nationwide for lodgment
- Forward soft copy of schedules in excel format to zpcenquiries@zenithcustodian.com
- At the bank, ensure that customized deposit slip for the appropriate PFA is filled. Where there is no customized deposit slip, regular deposit slip can be used, while the following clearly stated on the slip:
 - Name of company
 - Name of depositor
 - Telephone number of depositor
 - Period cover of pension remittance
 - Where voluntary contributions are made kindly state the PIN Numbers allocated to you
 - Employees name and pin should be included when preparing the schedules.
 - Employee and Employer contribution should be stated before total.
 - Schedules should be properly summed up and checked by officer's in-charge before remittance.
